ADOPTION AND DONATION SCHEME FOR ZOO ANIMALS

The Zoos and Pheasantries of Himachal Pradesh are governed by the Wildlife Wing of Himachal Pradesh Forest Department and operated under the aegis of Himachal Pradesh Zoo and Conservation Breeding Society (hereinafter referred to as the "Society"). The Society is responsible for the management of the Zoos and conservation of endangered species in the Pheasantries through respective zoo authorities. The Society organizes various awareness and education programmes in the Zoos of Himachal Pradesh for the School children, students, and visitors, general public and civil society. The Society bears the costs of the infrastructure development and maintenance of the Zoos in Himachal Pradesh and animals therein. The Society receives the funds through Grant-in-aid and the revenue generation from the Zoos which is barely sufficient to meet with the annual requirements of the Zoos The Animal adoption and donation scheme is being formulated to engage the general public, animal lovers, civil society, corporates, NGOs etc. in wildlife awareness and protection and contribute towards mainstreaming efforts in the field of wildlife conservation. The scheme shall supplement the income of the society so that better facilities can be created and provided to the general public and maintenance upgraded in the Zoos of Himachal Pradesh.

ANIMAL ADOPTION

Animal adoption is a novel way of showing your love, support and care for the wild animals. It is a unique way of connecting to the wild animals in the Zoos and contributing towards the wildlife conservation. The general public, animal lovers, civil society, corporate, NGOs etc. can choose an animal of their interest in the Zoo and contribute financially towards its maintenance (feed, vaccination & treatment included) expenditure for over a period of one year. One can choose between adoption or donation and also choose from the different categories of wild animals while making a contribution to the Society. An adoption makes a great gift for birthdays; anniversaries etc., and is always unique. The adopters/ donors shall be eligible for different benefits as per the category chosen and donation/ adoption also comes with benefits under the Income Tax Act.

HOW TO ADOPT A ZOO ANIMAL

- 1. Pick your favourite animal from the list of the Zoo animal.
- 2. Choose a category of adoption and donation scheme
- 3. Fill in the Zoo animal adoption form and hand it over to the Zoo authorities along with your contribution. Online adoption/ donation will also become available later.

(B) Entire Zoo Adoption

An entire Zoo or Pheasantry can be adopted for one year with contribution of Rs 1 crore /annum and a contribution of Rs. 25 lakh each for the Pheasantries at Manali, Sarahan & Chail. This Scheme is tailor-made for CSR contribution.

(C) Rescue Centre Adoption

There is one Rescue Centre located at Tutikandi Shimla which gives shelter to wild animals specially leopards and black bears that are injured & cannot be released back into the wild. These animals require love and support for their entire lifetime. The Rescue Centre can be adopted for one year by making a contribution of Rs. 1.0 crore per annum.

Privileges for entire Zoo/ Pheasantry/ Rescue Centre Adopters

In addition to the privileges available to the Category I animal adopters, such esteemed donors shall be invited as 'Guest of Honour', during opening and closing ceremony of Wildlife Week, to participate in major WL events (workshops, seminars, inaugurals& annual Pong Dam Lake bird count exercise etc.). They shall be entitled to rent free stay for up to 12 days (two sets) in a Rest House maintained by HPZCBS anywhere in the State. Their names shall be published on the WL Website (upon request) as esteemed and honoured donors. A display board of 3' x 2' shall be put up the main entry gate (on request) of the Zoo/ Pheasantry exhibiting clearly the name of the Zoo/ Pheasantry adopter and illustrating that the particular Zoo/ Pheasantry has been adopted by the donor for the period from......

(D) Donations

Donations can be made to the Society at Zoo Souvenir Shops by animal lovers in any amount. Donations up to Rs. 1000 can be made in cash against Society receipt. Higher amounts may be contributed through debit/ credit cards/ UPI (facility to be made available soon) cheques/ demand draft/ bankers cheque against the Society receipt. Online contribution facility through UPI & debit/ credit card shall be made available on the WL Wing Website soon.

OTHER BENEFITS OF ANIMAL ADOPTION AND DONATION

1. All the Zoo animal adopters shall be eligible for up to 50% of amount donated for exemption under section 80G of the Income tax Act, 1961 under section 80G (5) (vi) of the Income Tax Act, 1961.

2. All the animal adopters shall be sent special invites for the seminars, workshops and other events organized by the Zoo and shall be considered

3. The corporate entities, NGOs can reach to larger audience through their

publicity in the Zoo.

4. The Animal adopters can gift an adopted animal to children, friends and relatives for the special occasions like birthdays, anniversaries etc. which means that the adoption certificate will be transferred in their name.

5. The animal adopter can earn satisfaction in contributing towards the animal

welfare and conservation of wildlife.

TERMS AND CONDITIONS OF ANIMAL ADOPTION AND DONATION SCHEME

- 1. Any interested person or party wanting to adopt animals can choose which animals would interest them and contribute for their care, after filling up the application form (Annexure I) and by entering into an agreement with zoo management (Annexure II). A Certificate of Adoption (Annexure III) shall be issued to them.
- 2. Entire Zoo/ Pheasantry/ Rescue Centre adopters can choose which Zoo/ Pheasantry/ Rescue Centre to adopt by filling in the application form (Annexure IV), making their contribution and entering into an agreement (Annexure V). A Certificate of Zoo/ Pheasantry/ Rescue Centre adoption (Annexure VI) shall be issued to them.
- 3. Contribution for animal/ zoo adoption may be paid by Account Payee Cheque, Demand Draft, Credit or Debit card, QR code scanning to the respective Zoo.
- 4. Renewal can be made by e-mail at hpzcbsshimla@gmail.com.
- 5. Adoption memberships are neither transferable and nor refundable.
- 6. Adoption membership details except those displayed or published (on request) shall be kept confidential and shall not be shared with other organizations without prior permission of the concerned adopter.
- 7. If approached by the media on Zoo grounds he/she should refrain from answering any questions or sharing his/her opinions on a Zoo matters, unless it has been previously approved by the Zoo management.
- 8. Adoption of zoo animals will be of one/two years.
- 9. The adopter may withdraw his/her adoption at any time. But in that case, no money will be refunded.
- 10. The adopter may select the animals for adoption as rate provided in Scheme which may be revised from time to time by the Society.
- 11. Adoption membership may be terminated, if any misconduct, misbehavior, misuse of the membership of adoption is observed or any criminal case pending against adopter in the court of law or submit any false information.

12. Since, the adoption & donation Scheme comes with Income Tax benefits, it is not possible to claim refund.
